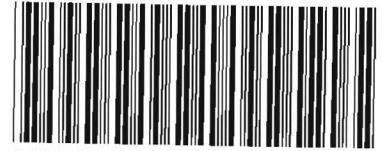

THE BOARD OF COUNTY COMMISSIONERS

AN ORDINANCE REPEALING ORDINANCE NO. O-991-001, AN ORDINANCE PERTAINING TO THE REGULATION OF NOISE ON PUBLIC AND PRIVATE PROPERTY IN THE UNINCORPORATED TERRITORY OF DOUGLAS COUNTY, AND ORDINANCE NO. O-992-002, AN ORDINANCE AMENDING ORDINANCE NO. O-991-001 PERTAINING TO THE REGULATION OF NOISE ON PUBLIC AND PRIVATE PROPERTY IN THE UNINCORPORATED TERRITORY OF DOUGLAS COUNTY

WHEREAS, on August 14, 1991, the Board of County Commissioners ("Board") adopted Ordinance No. O-991-001, An Ordinance Pertaining to the Regulation of Noise on Public and Private Property in the Unincorporated Territory of Douglas County; and

WHEREAS, on August 26, 1992, the Board adopted Ordinance No. O-992-002, An Ordinance Amending Ordinance No. O-991-001; and

WHEREAS, the Board now wishes to repeal both Ordinance No. O-991-001 and Ordinance No. O-992-001; now, therefore,

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, as follows:

1. Ordinance No. O-991-001, An Ordinance Pertaining to the Regulation of Noise on Public and Private Property in the Unincorporated Territory of Douglas County, is hereby repealed.
2. Ordinance No. O-992-001, An Ordinance Amending Ordinance No. O-991-001 Pertaining to the Regulation of Noise on Public and Private Property in the Unincorporated Territory of Douglas County, is hereby repealed.
3. Severability. If any section, subsection or clause of this ordinance shall be deemed to be unconstitutional or otherwise invalid, such validity shall not affect, impair or invalidate any other provisions of this ordinance, which can be given affect without such invalid provision.
4. This repeal shall not affect or prevent the prosecution or punishment or any person for any act done or committed in violation of the ordinances referenced herein prior to the effective date of this ordinance.
