Arapahoe County has not funded the Aurora-South Metro SBDC since the fiduciary host office relocated from the South Metro Denver Chamber to the City of Aurora in September 2014.

Financial Assistance Requested:

Due to the tremendous increase in services requested by citizens, we find ourselves in need of additional human capacity in order to meet client needs. Our plan is to fund two new positions beginning now (2021) and for three years into the future (2022, 2023 and 2024) in order to grow the economic impact in the south metro area.

Associate Director for the South Metro Area – Budget Need: \$125,000 annually Full-time Consultant for the South Metro Area – Budget Need: \$100,000 annually Programming/Operational Budget Need: \$25,000 annually
