The purpose of this memo is to inform the Board of items and emerging issues that may be of interest.

• New ordinance limits commercial passenger unloading in Douglas County - Board of County



Commissioners approves new ordinance to protect community health, safety, and well-being amidst national migrant crisis

A new county ordinance – effective immediately – aims to ensure only the planned, scheduled, and documented arrival of commercial passenger vehicles in unincorporated Douglas County.

During a special business meeting Tuesday, the Board of Douglas County Commissioners voted unanimously on second reading to enact the ordinance, which limits the unloading of commercial passengers in unplanned locations. The new ordinance is intended to proactively address the national migrant crisis – which, by the end of January 2024 saw more than 40,000 migrants arriving in Denver, more per capita than any other city in the United States, according to the New York Times.

Under the ordinance, the driver of a commercial vehicle may not stop and unload passengers in unincorporated Douglas County other than at planned, scheduled and documented destinations. Drivers who violate any section of the ordinance commit a civil infraction as defined in State Law and may incur a fine of up to \$1,000. The vehicle may be deemed a public nuisance under the law and may be subject to seizure. With the passing of second reading Tuesday, the ordinance goes into effect immediately. This ordinance process is defined for local governments in Colorado State Statute.

This ordinance is the second of two actions the Board is taking to address the national migrant crisis at the local level. In March, the Board also <u>decided to take legal action</u> so that local law enforcement can fully cooperate with federal immigration officials. Your community's overall wellbeing is at the forefront of these tough decisions as your Board of Douglas County Commissioners works to address local impacts of the national migrant crisis. <u>Watch a Live Town Hall</u> from March to learn how your community is working together to address homelessness and to proactively address this national issue.

• Ready to respond: Aerial firefighting support secured for your safety in 2024 - Douglas County



contracts (full story)

At the March 26 Business Meeting, The Board of Douglas County Commissioners allocated more than \$1.8 million to the County's 2024 wildland fire <u>aerial firefighting contracts</u>, ensuring air support in Douglas County is available at a moment's notice in the event of a wildfire.

A contract with Trans Aero LTD, for \$1,505,000 will provide 183 days of exclusive use of a Type 2 helicopter to Douglas County – 30 days of additional coverage compared to 2023. A Type 2 helicopter capable of delivering 300 gallons of water to the front lines of a wildfire will be standing ready to respond from June 1 through Nov. 30, 2024. Additionally, from March 27 through Dec. 31, 2024, three call-when-needed air support contracts were approved for use, each for up to \$100,000. Three aerial wildland firefighting vendors are capable of providing Boeing DC-10 Air Tankers and numerous helicopters capable of delivering thousands of gallons of water to the front lines of a fire, which may assist as needed with wildfire suppression. Douglas County is the only local government in Colorado with an aerial support plan for wildfire.

The <u>Douglas County Wildfire Action Collaborative</u> exists to facilitate innovative approaches for bolstering community wildfire resilience. Their programs include the Community Wildfire Protection Plan, Wildfire Evaluation Risk Map and Wildfire Mitigation Defensible Space Program. You can also do your part to prepare for wildfires by doing <u>mitigation work</u> around your property and creating a defensible space between vegetation and your home. Resources available in Douglas County to help families save money and prepare include a <u>Wildfire Mitigation Cost-Share</u> program and a free-use <u>slash-mulch site</u>.

Please also sign up every phone line in your household for <u>CodeRED</u> notifications, ensuring you receive emergency notifications. - Other activities:
 - O Staff member Tom Kenny completed a two-week National Aerial Supervision Academy in Phoenix, AZ, funded by the US Forest Service and Bureau of Land Management. This was an extremely rigorous training academy with numerous real-time and simulated flight hours spent training, coaching, and evaluating students in the logistical and operational coordination of aerial resources from an aerial platform. Tom's successful completion of this academy qualified him to begin real-world training on wildfires across the country this summer, leading to his eventual qualification as an Air Tactical Group Supervisor (Air Attack). This qualification is exceedingly difficult to achieve and would make Tom one of only a handful of qualified Air Attacks in the metro region.
 - Staff continues holding Colorado Emergency Preparedness Assessment Pre-Assessment Meetings with affected departments
 - o Staff continues working with partners on the Regional Alert and Warning Framework
 - Staff provided OEM/EOC Orientation for the current DCSO Community Safety Volunteer Academy

Human Services

• You told us one of your top priorities for older adults was affordable housing. Your county is continuing to invest in that priority (<u>full story</u>)

During a regular Business Meeting Tuesday, March 26, the Board of Douglas County Commissioners approved \$850,000 in grant funding for the RidgeGate Senior Apartments, a project of the <u>Douglas County</u> Housing Partnership.

The first phase of the project, located near I-25 and RidgeGate Parkway, includes 101 residential units



exclusively for older adults and is 100% affordable – income limits for residents will average at or below 60% of the area median income. The complex is expected to open in summer 2025 and be home to 128 adults who are 55 or older. This is the second investment in affordable housing for older adults in 2024. In January, Commissioners approved a loan for the Douglas County Housing Partnership to improve an older adult community in Castle Rock. Funding for the grant is remaining federal funding generated

from <u>Community Development Block Grants</u> – a program of Housing and Urban Development (HUD). Douglas County Housing Partnership will use the grant specifically for land acquisition.

We know our older adults want to stay in Douglas County as they retire. Douglas County's Older Adult Initiative launched in March 2023 to understand the resources our older adults need to do just that. To learn more about the Older Adult Initiative, visit our webpage.

• Adult Protective Services (APS) and Child Welfare recently completed audits with the Colorado



Department of Human Services, Administrative Review Division (ARD). The ARD conducted its annual review of closed Assessment/Investigation and Provisioning of Services for APS on February 1-8, 2024. Quality Assurance reviews are conducted on a random sample drawn from the county's overall Assessment/Investigation, Provisioning of Services, and County-Held Guardianship populations. Any area scoring 90% or higher was considered a Strength and any item falling below 70% was considered an Area Needing Improvement. Some of the strengths in the practice area

of Assessment/Investigations included: Allegations Correctly Identified, Client, Perpetrator and Collaterals Interviewed, Investigation Completed Timely, Case Plans Completed Timely, and Monthly Contacts Completed Timely. Some areas needing improvement included: Unannounced Client Visits, Home/Residence Mitigating Services and Final Medical Mitigating Services. Overall, APS has a strong practice and scored at or above the 90% threshold in most areas.

The Child Welfare review was held March 25-28, 2024. This was our first review since 2017. Quality



Assurance reviews are conducted on a random sample drawn from the county's overall Assessments that were accepted during the six-month review time frame, July 26, 2023 – January 26, 2024. The second review population was In-Home cases with an open involvement longer than the past six months, opened on or before August 26, 2023. For purposes of interpretation, any area scoring 95% or higher is considered a Strength. This aligns with the percentage required to be in substantial conformity on the federal Child and Family Services Review. Any item falling at or

below 70% is considered an Area Needing Improvement. The final report will be release in May, however preliminary findings indicated strengths in completing thorough assessments/investigations, accurate overall findings, family engagement, and monthly face-to-face contact with the children. Some areas identified as needing improvement were timely completion of the safety assessment tool, supervisor approval, and face-to-face contact with parents. Overall, our practice was described as very strong and there were several assessments and cases with zero errors.

• Arapahoe/Douglas Works! Success Story: A customer was referred to A/D Works! and the Employment First Program as an adult with no dependents receiving SNAP benefits. She was interested in job search support and resources in hopes of gaining employment in the profession of Emergency Management. She had recently earned her degree in Emergency Management and Homeland Security during the COVID-19 pandemic but was not able to gain any hands-on experience due to restrictions and was struggling to break into the industry.

The customer worked with Employment First virtually to address struggles she had getting responses to



applications. She was connected with the business development team for support finding job postings and networking opportunities, including contacts for interviews. She was referred to several hiring events and job opportunities with Denver Public Schools and other local government and non-profit organizations. She also attended virtual resume and interviewing workshops and 1:1 reviews to better enable her to target her resumes to her specific industry. She received

supportive services including transportation, clothing for interviews and tools needed for day-to-day work.

The customer was hired by a local public school system as an Emergency Management Specialist. She began working full time and received an offer for starting pay of \$31.38 and benefits. She recently completed her job retention phase allowing her to settle into her new opportunity and stated she felt supported and set up for success in her new career.

Public Health Department

Curbside Service offered for Household Hazardous Waste (full story) - If you have recently painted your



house, changed your car's oil, or spruced up your lawn, you likely have products that require proper disposal to keep your family and our community safe. The Douglas County Health Department is partnering with Waste Management and other local jurisdictions to provide a low-cost household pickup service for hazardous waste removal year-round. Get details and sign up for your household pick-up at Waste Management's website. The cost is \$30 for Douglas County residents. To learn what items are accepted visit the household hazardous

waste webpage. This program is designed for residential use only. Items must relate to reasonable homeowner activities.

If you just have paint, consider using one of the free drop-off locations offered through Colorado's PaintCare program. If you have more than 10 gallons, call PaintCare at 720-854-8722 to see if you qualify for a free

Mental Health Awareness Month - Did you know, 20% of adults and 17% of youth experienced a mental health challenge last year? Mental health challenges happen to a lot of us; yet the stigma, cost, location and lack of resource awareness keeps people from talking about it or seeking care. May is Mental Health Awareness Month. - Improving ventilation or gathering outdoors

HEART Activity Report – March 2024









- **HEART Success Story:** The HEART received a referral from the Parker Police Department of a woman living out of her vehicle. A HEART Navigator met with the woman to assess her needs and barriers. The woman was newly evicted from her apartment, working two jobs, and struggling to find enough funds to repair the vehicle that she was residing in. A local non-profit paid to have her vehicle repaired, and the HEART was able to refer her to organizations to help with a motel voucher while her car was in the auto shop. The woman was able to gather enough funds to register her vehicle and she currently has an apartment application pending. Staff is working with the woman to ensure she is connected to an agency that can provide her with long-term case management and budgeting assistance so that when she does get into a place of her own, she can regain self-sufficiency.
- Homeless Prevention Activities Program Grant Application Staff submitted an application to the Colorado Department of Local Affairs for the Homeless Prevention Activities Program Grant in the amount of \$50,000. If awarded, funding will be used to help residents avoid homelessness through financial assistance, case management, and supportive services. The State anticipates notifying recipients by May 15, 2024.
- **HEART Update** We congratulate Kim Alvarado and Britt Johnson for completing their six-week training program with the HEART. With their completed training, we are excited to announce that HEART coverage will be expanded to Sundays from 8-6 pm beginning April 7, 2024.

Parks, Trails and Building Grounds

- Parks and Trails Volunteer Update Three volunteer events were hosted in March:
 - o On March 20, 2024, one volunteer provided two hours of service at Bigham Lake for shoreline cleanup and collected two bags of trash.
 - The trash pick-up event at Highland Heritage Regional Park on March 21, 2024, was attended by five volunteers who provided 10 hours of service and filled six bags of trash.
 - A trash pick-up event at Fairgrounds Regional Park on March 27, 2024, was attended by three volunteers who provided six hours of service and collected three bags of trash.

• Parks Operations Update

Tree Debris - The aftereffects from the March snowstorm are still being felt in the Parks Division. Over two feet of heavy, wet snow fell in some areas of the County, causing damage to many trees throughout the area. Much of the damage left safety concerns for the public and those issues were handled as soon as crews completed the snow removal. Parks staff have inspected, trimmed, and removed many obstacles in both the trail system and in the parks.



O Spring Preparations - One of the strategies that Parks staff uses to manipulate Mother Nature is using a product called Grow Blankets. Grass seed will only germinate when soil temperatures reach 50 degrees and in Douglas County, that can be as late as May. Grow Blankets create a greenhouse effect which helps raise soil temperatures while allowing moisture and air to move freely through the material giving the grass a head start on the season. Parks staff uses this product in County dog parks and in goal areas for soccer to establish the grass earlier than normal to preserve the high traffic areas.

• Rueter-Hess Updates - Safe, Family Friendly Experiences - Upon a request from the Recreation Advisory Board, Rueter-Hess Rangers conducted research regarding improving the fishing experience at the reservoir. As a result, two pedal pontoon boats, as well as two rowboats, will be available for customers rent this summer.





• Trail Corridor Clearing - Rangers are continuing efforts to clear the corridor along the Coyote Run Loop trail. A properly cleared trail will limit unwanted wildlife interactions, improve the line of sight, and allow the trail to dry out faster after the rain or snow.

Public Works

Activities for March 25 – April 5, 2024

New completion date for University/Lincoln and Quebec - Expect extended daily delays in exchange for an overall shorter project duration. Ask your questions at a Live Town Hall at 6 p.m. Thursday, April 25 (full story)

If you've been driving through the intersection of University/Lincoln and Quebec and wondering when



construction will ever end, you'll be glad to know the project is now expected to be completed before school starts in early August – 46 days earlier than originally scheduled. How? Read on.

Construction to improve road quality and safety at the intersection began last year. The original construction schedule was designed to reduce travel time delays by scheduling the heaviest impacts


between 8:30 a.m. and 3:30 p.m. The original completion timeframe was fall 2024.

For the contractor to finish early, crews need more time on the road. Starting this week, all directions will be reduced to one through lane 24/7. As construction progresses, additional lanes will open. The time saved installing and removing traffic control daily and longer work hours result in the schedule gain.

Active Projects

• US 85 Widening from Highlands Ranch Parkway to C-470 Improvements – Major impacts this week:



- Large machinery is present in the area as crews continue underground foundation operations on the eastern portion of the new bridge over C-470.
- Single lane closures on northbound and southbound US 85 and on the C-470 ramps at US 85 from 9 a.m. to 3 p.m. daily, Monday, April 1, through Saturday, April 6, throughout the corridor.


• Roxborough Park Road Construction Project - Project started on February 20, 2024. This work involves scrapers and haul trucks traveling from the east to west on Roxborough Park Road, creating stockpile placement for filing 7A in Sterling Ranch.

There will be a road closure on Roxborough Park Rd for one year (to re-open on March 26, 2025). This closure is for the placement of fill for the improvements on the graveled portion of Roxborough Park Rd. The closure is on Roxborough Park Rd between Waterton Rd and Titan Rd. Detour routes are posted.

A Traffic Control plan is in place from 8 a.m. to 5 p.m., Monday through Friday. No Saturday work planned. Anticipated completion will be in 2027.

• Two Bridges Subdivision Sidewalk Repair Project - Sidewalk repairs are underway in the Two Bridges subdivision on Hopsage Circle, Red Primrose St., and Arnica Way. Minimum traffic impacts. Construction is anticipated to be completed within 10 calendar days. View more information about the project.





- Highlands Ranch Parkway Manholes Project (between Burntwood and Goldsmith) Construction on the manholes (storm sewer structure) began on Highlands Ranch Parkway between Burntwood and Goldsmith on February 5, 2024. Both have been completed.
- County Rd 105 Bridge Rehabilitation over Oakland School Gulch Project Motorists can expect single-lane traffic with temporary traffic signals guiding motorists through the work zone.



The County Road 105 Bridge Rehabilitation over Oakland School Gulch Project consists of rehabilitating



153 feet of a bridge structure and roadway crossing over Oakland School Gulch. Douglas County maintains this section of roadway north of Wolfensberger Rd, also known as N. Perry Park Rd. Anything south of Wolfensberger Rd is known as Colorado 105 and is a CDOT maintained roadway. The project includes removing portions of the present structure, asphalt milling, joint sealant,

waterproofing membrane, hot mix asphalt placement, concrete patching, erosion control, traffic control, as

well as other items.

Construction will begin on February 19, 2024. Anticipated completion date will be 90 days later. West Fork Construction is the Contractor, and the Project is estimated to cost approximately \$615k.

Green Meadows Drive (Highlands Ranch) Storm Sewer Maintenance Work
 Green Meadows Drive (between Green Meadows Ln and Blue Mountain Pl) was closed between April 3 - 5, instead of April 8 - 11 as was previously planned due to weather being better than expected.

• Bayou Gulch Road Project – Bayou Gulch Road, between Scott Ave and Vistancia Drive, will remain closed until May 2024. The project will be in winter shutdown and construction operations will be limited until March 2024. During this time, the road is closed to pedestrians, bicycles, and motor vehicles, including weekends, evenings, and holidays. Access to the Vistancia neighborhood is now open through the north entrance.

In the Spring of 2024, the contractor will complete final components of seeding and mulching, top mat asphalt in Phase B, signing and striping for Phase B, and punch list items for close out in both Phases A and B. Construction started on June 26, 2023 and is expected to be completed in May 2024. View more information about the project.

• Sterling Ranch – Villalobos Construction is installing gas line and Three Sons Construction is starting subgrade preparation at Yellowcress and White Clover in Filing 6 (DV 2021-286).

Cielo Subdivision – Prime Construction is lowering a manhole at the intersection of Vista Arroyo and Estancia (DV2016-195). Streets under construction: Las Rosas Dr, Santa Cruz Pt, Cristobal Pt, Las Cochase Pt and Las Palmas Pt.

• Cross Creek Subdivision – Three Sons Construction is installing storm sewer and manholes in Filing #1 (DV2023-121).







• Emergency Investigation - Sunday, March 24 at 3:30 a.m. Douglas County Sheriff's dispatch requested a Building Inspector on behalf of South Metro Fire Rescue to respond to a vehicle impact to a home in the Stonegate subdivision. The vehicle impacted the garage of the home at a high rate of speed after snapping off the light pole in front of the house. The garage was structurally compromised. South Metro crews shored-up the damaged area allowing the occupants to remain in the home while repairs are scheduled and performed. No serious injuries were reported to the occupants of the vehicle and the homeowners who were sleeping at the time were not injured.



- Letters of Credit (LOC) A sight draft approval was requested to make a draw upon the GESC Permit security for Meridian International Business Center Filing 6, 9th Amendment, VF Hanger DV2021-096. The LOC will expire on April 13, 2024. No draw will be made if the developer, Tectonic Management Group, extends the expiration date.
- Legislative CDPHE Dredge and Fill Draft Bills:




- O SB24-127 Regulate Dredged and Fill Material State Waters: This bill proposes to create the Stream and Wetlands Commission and would house the Dredge and Fill Permit program in the Department of Natural Resources. The 1st committee hearing is scheduled for April 11.
- HB24-1379 Regulate Dredge and Fill Activities in State Waters: This bill proposes to place the Dredge and Fill rulemaking under the purview of the Water

Quality Control Commission and would house the program in the Colorado Department of Public Health and Environment. The 1st committee hearing is scheduled for April 8.

Traffic

- Traffic Management Center (TMC) Tours To increase public awareness of the capabilities of the TMC, traffic staff offers tours on a monthly basis to interested individuals or groups. Within the last few weeks, staff hosted three tours:
 - Existing TMC Technologies Tour for Dr. Qichao Wang, Sebastian Barry (NREL), Faizan Mir (NREL), and Todd Osborn (Mines/NREL) – Dr. Wang is working on future technologies

- Amendment to Pilot to Allow Temporary Signs on County Owned Property Staff provided a recap of the pilot program and the recommendation to include an additional time (May 3 through July 9), because of all the elections in 2024, to the initial time frame (currently October 5, 2023 through December 31, 2024). The Pilot program will be evaluated at the end of 2024 to determine whether to make it a permanent policy. *Motion* Follow the recommendations of Public Works and Engineering staff regarding free speech zones for the periods identified. Passes 2-1. Commissioner Thomas opposed.
