- **\$500,000 in federal funding approved for Douglas County roadway improvements** - An important



transportation project in Douglas County will receive federal funding this year. On Feb. 3, President Donald Trump signed a five-bill appropriations 'minibus' (a spending bill that includes fewer than 12 regular appropriations bills) into law, securing \$500,000 in community project funding for the widening of Highway 85 from Sedalia to Castle Rock, a much-needed improvement in the region. The \$500,000 is a direct result of federal engagement by the Board of Douglas County Commissioners in Washington, D.C., last year, as well as sustained action by Congresswoman Lauren Boebert. ## Community Services

### Activity Report February 6 - 19, 2026


- **HEART January 2026 Update:**



- **Housing Stability Program** - The Housing Stability Program (HSP) has completed the 2025 Homeless Resolution Program funding for eviction prevention, which began on April 1, 2025. During this time, the program assisted six unique households consisting of a total of 13 participants. Through the dedicated efforts of our community partners, more than 50 hours were spent providing comprehensive case management and wrap-around services to clients. Just over \$37,000 was allocated for rent assistance, effectively preventing evictions and ensuring households were able to maintain their current housing.

The County was awarded \$50,000 for the next grant period starting April 1, which will enable the program to continue offering exceptional services in collaboration with our HSP Partners. We look forward to maintaining our commitment to housing stability and supporting our community through this impactful program.

- **Douglas County Youth Initiative (DCYI): WrapAround–CASA Juvenile Justice Partnership** - The WrapAround Program has partnered with Court-Appointed Special Advocates (CASA) to provide structured, facilitated 360° action planning meetings for youth involved in the juvenile justice system. Now because of this WrapAround–CASA collaborative model families are no longer left to interpret court expectations on their own. The model represents a proactive, coordinated approach that is successfully moving youth toward stability, accountability, and long-term success.

## Parks and Recreation

### Parks Programming

- **Parks Volunteer Program** - The Parks Volunteer Program provides opportunities throughout the year for the community to give back to the outdoor spaces that our residents cherish. In 2026, there will be over 40 events across the County. Participants will have the chance to plant trees, flowers, and other landscape plants; clean up the shorelines at Bingham Lake and Rueter-Hess Reservoir; prune scrub oak along the East/West Regional Trail; eradicate noxious weeds; and more! View all opportunities and sign up at [douglasvolunteers.com](http://douglasvolunteers.com). The program kicked off the 2026 season on February 14th, with a shoreline cleanup at Bingham Lake. Eight volunteers spent three hours in the morning collecting four bags of trash.



### Rueter-Hess Reservoir

- **New Entrance Station** - On February 2<sup>nd</sup>, the Rueter-Hess property received its new entrance station (see below right). This new entrance station is one of the improvements that will enhance the guests' experience entering the park. To date, the old entrance station (pictured below left) has served over 20,000 guests in the past 3 years. In addition to being more visibly inviting, the new entrance station will better enable park rangers to serve guests by providing a faster, safer, friendlier arrival. The new entrance station is expected to be fully functioning and ready by the start of this year's watercraft season.



- Special Event Update** - The Rueter-Hess property continues to be a highly sought-after destination for community programming, hosting youth day camps that teach safe canoe, kayak, and paddleboard use, as well as signature events like the Town’s Dash Across the Dam 5K and community engagement days featuring paddle sports, fishing, and hiking. In 2025, the property successfully supported 27 special events, reflecting strong community interest and growing recreational demand. Looking ahead, we have already received 11 special-use requests for 2026, demonstrating continued enthusiasm for using the site for educational and recreational gatherings. These events play an important role in connecting residents to outdoor experiences while reinforcing the property’s value as a regional asset. Our team remains committed to supporting safe, well-organized, and memorable events throughout the upcoming season.



## Public Works

### Activity Report February 9 – 20, 2026

- Four-way stop coming to Crystal Valley Parkway and Lake Gulch Road - Attention drivers in the Plum Creek Area of Castle Rock!** Due to increased collisions, Douglas County crews installed all-way stop signs at the intersection of Crystal Valley Parkway and Lake Gulch Road on Wednesday, Feb. 18. This improvement is intended to reduce crashes, clarify right-of-way, and improve safety for all drivers, cyclists, and pedestrians traveling through the intersection.



### Active Projects ([Cone Zone Webpage](#))

- County Line Road Widening and Reconstruction** – Construction on County Line Road began in September 2025. As of, Jan. 6, 2026, County Line Road was fully closed for approximately 100 days between Clarkson Street and the U-Haul business access. This closure is required for crews to safely import, move and place large quantities of dirt, equal to filling 40,000 washing machines, at Lee Gulch. The fill operations, which are a key component of the widening and reconstruction work, will level out the roadway by removing the dip at Lee Gulch, improving drainage, driver line of sight and overall public safety. [Visit our webpage for closure details beginning in January 2026 and lasting through mid-April](#) Since 2019, Douglas County has worked with partners to advance the final design, acquire right-of-way, and prepare utility relocation design for a major water line located within the project area. Douglas County is partnering with the Denver Regional Council of Governments, City of Littleton, and City of Centennial to fund the project.
- I-25 Douglas County Monument Signs** – Cushing Terrell has begun producing construction plans for both the north and south monument signs. The project team has received initial comments from CDOT and is working to address them. Once CDOT approves the design the application will continue to the Federal Highway Administration for approval. Approval is expected to take several months.



- [\*\*Hilltop Road \(Legend High School to Crest View Drive\) Improvements Project\*\*](#) – For segment 1 of this project, the construction began on April 16, 2025, and the contractor began implementing public notifications on message boards. This is the first of three projects planned over the next few years to reconstruct and widen the Hilltop Road and Singing Hills Road corridors. The project has a 16-month completion date and is anticipated to be finished in September 2026. Phase 2 of Construction is anticipated to begin in 2027; and will take 9 to 12 months to construct. Phase 3 of construction is anticipated to begin in 2029 (pending funding); and will take 12 to 18 months to construct.



There have been questions from citizens about the new roundabout construction at the intersection of Crestview Dr and Village Rd on Hilltop Rd, which will eliminate the existing two-way stop-controlled intersection. Here is the map: [Roundabout Rendition/Map](#).

- [\*\*Pine Creek and Highway 67 Culvert Replacement Project\*\*](#) - Two culverts on Pine Creek Rd and three culverts on Douglas County Highway 67 need to be replaced. The existing storm culverts vary in size from 36” diameter to 48” diameter and are made of metal. We are anticipating that this work will occur Fall 2025 – Spring 2026. These culvert replacements will have roadway impacts and travelers to the area should expect long delays.



- [\*\*Waterton and Eagle River Roundabout Project\*\*](#) - Construction started on December 8, 2025, and is anticipated to be completed by March 8, 2026. [View Roundabout Plan here](#)



- **Phase 1** was completed on Friday, February 6, 2026.
  - **Phase 2** Traffic switch will remain in configuration until the first week of April. This configuration includes opening lanes on Waterton Rd in both directions of traffic as well as opening Eagle River St to the south. The north side of Waterton Rd will be closed and access from Eagle River St to the north of the intersection will also be closed. [Detour Map for the Work Zone](#)

- Highlands Ranch Pkwy Reconstruction, Broadway to Burntwood** - County received final design on February 6th and are beginning to assemble the bid documents. The project is planned to bid April 7th, and construction will begin in early summer of 2026.

- [\*\*Broadway at Northridge Recreation Center Storm Sewer Maintenance Project\*\*](#) – Staff have begun the maintenance phase of this project for the 54” Corrugated Metal Pipe (CMP) located along the front of the Northridge Recreation Center in Highlands Ranch, and the dual 126” CMP storm culverts that are located under Broadway at the Northridge Recreation Center.



On Monday, February 16, 2026, the contractor began lining the 90” storm sewer from Wildcat Reserve Pkwy and University to the outfall north of Lark Sparrow Dr. The right turn lane from northbound Wildcat Reserve Pkwy to eastbound University will be closed for approximately 6 weeks and the through lane will become the through/right turn lane during this time; and the sidewalk on the east side will also be closed. Pedestrians will need to cross from the east side of Wildcat

Reserve Pkwy to the west side at the signalized intersection south of the work zone which is Grace Blvd/Cresthill Ln or cross to the west side of Wildcat Reserve Pkwy to access Fallbrooke or to head south to Grace Boulevard. The contractor will also be staging on the north side of Lark Sparrow Dr and there will be a traffic shift there also, but lanes will remain open. Access to Eastridge Rec Center and Falcon Park will not be impacted.

- [Traffic Striping and Markings Projects](#) - On Wednesday, Feb. 18, 2026, Traffic Signs and Markings crews installed an all-way stop condition at the intersection of S. Lake Gulch Rd and Crystal Valley Parkway.



- **2026 Pavement Management**

- The 2026 Sidewalk Repair Project was bid on December 9<sup>th</sup>. Chato's Concrete LLC was the apparent low bidder with a bid of \$2,279,120.00. This is 9% below the engineer's estimate. Work is expected to begin in March.
- The 2026 Guardrail Repair Project bid on December 16<sup>th</sup>. The apparent low bidder submitted a bid package that was found to be insufficient; the next low bidder is Cruz Construction. The bid amount from Cruz Construction was \$150,090.00 which was 25% under the engineer's estimate. A pre-construction meeting is scheduled for February 5<sup>th</sup>.
- The 2026 Asphalt Overlay Project bid on December 2<sup>nd</sup>. The apparent low bidder was Martin Marietta Materials, Inc. with a bid of \$10,230,041.55 which was 13% below the engineer's estimate. Work is expected to begin in May.



- **Jones Road** – Matrix Design Group was selected as the design consultant for the design of the Jones Road project. The project includes asphalt paving of the roughly 3-mile road as well as drainage improvements. The project will be constructed in phases. A concept design has been selected, and the team is working towards the final design of the first phase.

- [Grigs Road Paving Project – Phase 2](#) - RS&H was selected as the design consultant for phase 2 of the Grigs



Road project. Phase 2 will start where phase 1 ends, near the East-West Trailhead Parking Lot and will continue north onto the existing concrete road. The project includes realignment of the road, drainage improvements, a parallel pedestrian trail, and asphalt paving. The consultant has developed concept-level designs for the roadway and adjacent trail. A virtual open house is being developed to share the concept designs and solicit feedback from the public. Survey and geotechnical work continue. This project is scheduled to be


constructed in 2027.

- **Quebec and Park Meadows Dr Intersection Improvements** – Basis Partners met with County staff as well as RTD, CDOT, HRMD and Lone Tree staff in mid-December to review the concept designs. The concept design includes improvements from C470 to the lighted intersection south of Park Meadows Dr. The first phase of work is planned for 2026 and may include retiming of signals and upgrades to signs and striping. County staff is preparing the contract for final design with Basis Partners. They are expected to begin on final design in March.

- 2023 Bannock LID** - The design consultant, TST, is working on the design, with a preliminary design expected by the end of the year. County staff have reviewed the initial roadway design and provided feedback. The consultant is continuing the roadway design and beginning the drainage design. Once the preliminary design is complete, financing will be executed, and plans will be prepared for bidding. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)



- 2023 Spring Canyon LID** – The design consultant, TST, is nearing the end of preliminary design and will continue into final design. The CDPHE approval process for the proposed lift station continues. CORE and Black Hills Energy continue to work on the designs for electric and gas services. The county has received rough construction cost estimates as well as a proposal for final design work and the project is still on schedule for mid-2026 construction bidding. TST will begin reaching out to property owners in December to discuss design considerations. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)

## Public Health

## Open Space and Natural Resources

- **Barbed Wire Removal with Volunteer Trail Crew** - On Tuesday, February 10th, Open Space and Natural Resources (OSNR) staff and Trail Crew Volunteers went out to Hidden Mesa Open Space to remove unnecessary barbed wire. In total  $\frac{3}{4}$  mile of fencing was removed. This new project supports a broader initiative to enhance wildlife connectivity by reopening natural corridors. Removing unnecessary fencing reduces the risk of injury and entanglement for wildlife, allowing animals to move freely throughout the area. The next barbed wire removal will occur on Tuesday, February 24<sup>th</sup> at Spruce Mountain Open Space. This opportunity is open to the public on Douglas Volunteers!



- **OSNR Staff Install Memorial Plaque on top of Lincoln Mountain Open Space** - On February 17<sup>th</sup>, OSNR staff



worked through gale force winds, carried a steel rock bar and tamping bar to the top of Lincoln Mountain to secure a plaque memorializing Retired U.S Army Lieutenant Mark Maloney. The plaque was placed adjacent to a stone bench donated by Mark several years ago.

Mark is a Vietnam Veteran and former marathon runner who suffered an accident in 2020 that left him paralyzed. Lincoln Mountain was his favorite place in Douglas County and Mark has been a long-time advocate for the County's open spaces, trails, and for helping other accident victims and Veterans recover from injuries.

OSNR staff was honored to install the plaque for Mark and his family – it serves as a lasting tribute to his military service and contributions to the Douglas County community.



The event was a success across all measures, and we look forward to celebrating the 15th year of Castle Rock Bull Riding in 2027.

**Completed Projects**

- **Next Generation Teams and SharePoint Rollout Nears Completion** - The County’s Next Generation Teams and SharePoint Program is approaching full implementation. With recent deployments in Public Affairs, IT, HR, and Finance, this leaves two remaining departments, Community Justice Services and Clerk and Recorder, before countywide completion.

Each implementation has established a standardized Microsoft Teams collaboration environment, migrated legacy content, and provided structured training to support adoption. As part of this effort, outdated Teams have been migrated, and then the legacy Teams have been formally retired, strengthening security, improving records management practices, and enhancing cross-department collaboration.

This initiative represents a significant step forward in modernizing the County’s digital workplace infrastructure, improving operational consistency, and reducing long-term technology risk. A final update will be provided upon completion of the CJS and Clerk & Recorder implementations.

- **Tax Roll Interim Enhancements – Phase 2** - The County successfully completed Phase 2 of the Tax Roll Interim Enhancements project on February 5, 2026. This initiative ensured compliance with new state legislation requiring split property tax assessments, and previously, Phase 1 replaced the outdated Tax Roll application with a modern, flexible system. Delivered on time and at zero cost, the new Tax Roll System enables the Assessor, Treasurer, and IT teams to process and send tax notices seamlessly, including legislative changes, while improving efficiency and reliability. Citizens experienced no disruption, and tax notices were delivered on schedule, reinforcing the County’s commitment to exceptional service.
- **Geospatial Data Modernization Phase 2** - Phase 2 of the Geospatial Data Modernization Program has been successfully completed, advancing Douglas County’s geospatial capabilities through improved operational efficiency, streamlined workflows, and strengthened data governance. Our datasets are now more accurate, standardized, and enterprise-ready — positioning the County for future integration, advanced analytics, and AI innovation while supporting smarter decision-making and enhanced service delivery for our community.
- **ArcGIS Online Cleanup Phase 1** - The ArcGIS Online Cleanup Initiative has been successfully completed, modernizing and streamlining Douglas County’s GIS platform to make it cleaner, faster, and easier to use. Through organized content, standardized governance, and improved data integrity, we have established a stronger, more sustainable foundation for collaboration, innovation, and efficient service delivery across the County.

### Administrative Meeting – February 3, 2026

- The Board took action on several board and commission appointments, while identifying additional vacancies for future consideration. Public affairs updates included finalization of the County magazine, upcoming town halls, and multiple video projects pending RFP and draft review. The Board reviewed citizen correspondence related to development projects, public safety inquiries, and concerns about mayoral lunches, which commissioners defended as a high-value coordination tool, noting that some costs are personally covered by commissioners. Legislative discussion included opposition to state preemption of local drone authority (with final direction deferred) and continued prioritization of advocacy for a human trafficking bill currently in committee, along with direction to develop a focused legislative news landing page highlighting high-impact policy issues.

**Motion:** The Board directed staff to redirect the County’s nonprofit sponsorship efforts away from the Douglas County Community Foundation due to concerns regarding mission drift and management

standards and to begin the legal establishment of a new 501(c)(3) entity, tentatively named the Douglas County Foundation. Interim representation will be maintained during the transition. Passed 2-0.

**Motion:** The Board appointed Ed Hairfield to the Fair Board. Passed 2-0.

### **Commissioner Work Session – February 3, 2026**

- During the Work Session, the Board received detailed briefings and provided strategic direction on nonprofit restructuring, the 2026 Fair and Rodeo, building code updates, and legislative priorities. Commissioners affirmed direction to move forward with establishing the Douglas County Foundation to better serve approximately 800 nonprofits and 400,000 residents. The Fair Board presented its first formal business plan, which the Board requested to review and vote on at a future meeting, and staff received direction to pursue a second concert (Rock or 90s Alternative) on Parade Day and to relocate the Hometown Rodeo to the weekend prior to the Fair to reduce operational congestion. Strong early ticket sales were reported, and the Board reaffirmed support for community events, including Farm to Table revisions and staff appreciation events, noting the prior \$31,000 staff night was successful. Staff also briefed the Board on adoption of the 2024 International Building Codes and the state-mandated Wildfire Resiliency Code, with direction to continue evaluating Intergovernmental Agreements with fire districts to provide streamlined enforcement despite expected cost impacts to homeowners. Legislative discussion included intensifying advocacy for a human trafficking bill and planning for clearer public communication of the Board’s legislative priorities.

### **Commissioner Work Session – February 9, 2026**

- The Board reviewed proposed updates to Douglas County’s building codes and implementation of the state-mandated Wildfire Resiliency Code (SB 23-166). The County plans to adopt updated 2024/2026 International Building, Fire, Energy, and Electrical Codes by April 1, 2026 (no later than July 1, 2026) to avoid automatic imposition of more restrictive state “low energy” codes that would require full electrification of homes. The Board discussed the significant impact of the Wildfire Resiliency Code, particularly Class 2 hardening requirements, which mandate non-combustible materials for siding, decking, windows, fencing near structures, and landscaping changes within defined “structure ignition zones.” Commissioners expressed concern about retrofit triggers, where minor permits (e.g., siding or window replacement) could require full wildfire compliance upgrades. Staff was directed to pursue Intergovernmental Agreements (IGAs) with fire districts to streamline permitting as a “one-stop shop,” prepare template plans and public education materials, and explore zoning resolution updates to integrate wildfire standards and address HOA conflicts. Upcoming milestones include Planning Commission review in February/March 2026 and targeted Board adoption by April 1, 2026.

### **Administrative Meeting - February 9, 2026**

- The Board addressed governance transitions, public communication efforts, Retail Theft Ordinance refinements, and Fair event planning. Commissioner Van Winkle was appointed to the Douglas County Community Foundation (DCCF) Board following Commissioner Laydon’s resignation to maintain oversight during the County’s exploration of forming a separate foundation. Public Affairs reported on citizen engagement through the Citizen Connect portal and Commissioner Teal noted 32 direct constituent contacts after publication of his cell phone number. The County Attorney’s Office continues to revise the Retail Theft Ordinance, incorporating public feedback, and clarifying jurisdictional enforcement boundaries in unincorporated areas and Sheriff-policed municipalities. The County is transitioning from “Code Red” to “Doug Co Alerts,” requiring residents to re-register, with an internal employee test scheduled in March. The Board discussed formalizing recognition standards for Hall of Fame honors. Fair planning updates confirmed Trace Adkins as headliner (tickets on sale), evaluation of additional acts, potential multi-act scheduling changes, and inclusion of a drone show.
- The Board went into Executive Session to receive legal advice regarding a resolution to provide county support for Sheriff’s deputies involved in civil litigation to be considered the next day. Upon conclusion of

the executive session, the Board directing preparation of a brief public statement and routing media inquiries to the public meeting video for transparency.

- The Board reviewed multiple board and commission transitions, including Stephen Allen’s resignation from the Planning Commission and discussed nominating him to the Hall of Fame, temporary succession by Mark Witkiewicz, and consideration of Mark Reyher for appointment. Planning for the upcoming leadership retreat was expanded from 22 to approximately 55 attendees to include assistant directors, focusing on AI implementation and strategic planning. The Board previously approved a \$10,000 increase to the Douglas County Rodeo Queen Royalty Scholarship, and staff is coordinating planning discussions to align funding with program delivery.

### **Legislative Positions Briefing - February 11, 2026**

- The Board of County Commissioners convened following executive session to discuss negotiating positions and unanimously approved the following motions:
  - HB26-1138 - Retail Theft Prevention Program – Support.
  - HB26-1021 - Second Amendment Protection Act – Sheriff supports – Support.
  - HB26-1037 - Ban Government Purchase of Personal Data from Third Party – Oppose.
  - HB26-1126 - Requirements for Firearms Dealers – Oppose.
  - HB26-1144 - Prohibit Three-Dimensional Printing Firearms and Components – Oppose.
  - HB26-1114 - Allowed Minimum Lot Size for Subject Jurisdictions – Oppose.
  - SB26-043 - Record Keeping and Regulation of Sale of Firearm Barrel – Oppose.

Staff (Mariah and Josh) were directed to formally register and post the County’s positions. The Board also received an update from Treasurer Gill regarding HB 1119, which the Colorado County Treasurers Association strongly opposes and is currently under active negotiation; the Association’s analysis will be circulated to the Board for review.

### **Administrative Meeting - February 17, 2026**

- The Board convened an executive session to discuss negotiation strategy for an upcoming “Link on Demand” presentation. Following executive session, the Board reviewed public affairs topics. The Board finalized edits to the county magazine, which will be mailed within 7–10 days. The Board clarified and reaffirmed its public participation policy providing for public comment on every agenda item prior to a vote. Future initiatives will include coordinating a Town Hall on child internet safety prior to spring break, directing Communications to prepare a one-page resource guide for parents and host materials on the Healthy Families webpage. Commissioner Laydon gave an update of the Wildfire Action Collaborative, describing a GIS-based wildfire mitigation and evacuation software tool and noted plans to relaunch wildfire grants in Q2. Commissioner Laydon confirmed his plan to attend the NACo Winter Legislative Conference in Washington DC (February 20–24) and will convene a Metro Area County Commissioners (MACC) meeting on February 23 at the conference with Representative Brittany Pettersen to discuss SNAP funding, human services, wildfire mitigation, and Metro Area County priorities.

At the request of the County’s state lobbyist, the Board briefly discussed a recently introduced state senate bill, SB26-097, which would decriminalize commercial sexual activity between consenting adults. The Board unanimously voted to oppose the bill.

The Board briefly discussed board and commission appointments for Rocky Mountain RETAC, including Dr. Burt Katubig and Health Department employee Elijah Knecht, and began reviewing candidates for Cultural Council vacancies. The Board directed that departing Planning Commissioner Stephen Allen be recognized through a “Hall of Fame” honor and discussed potential replacements. Additional direction included pursuing a high-priority meeting with the new head of Colorado Parks and Wildlife regarding open space acquisitions and other potential partnership.
