• Life of a Ballot: Follow your 2024 General Election ballot through the process - What's the status of your vote? Track your ballot each step of the way. If you're a registered voter in Douglas County, you'll receive your ballot by mail and can track its status each step of the way. Watch this short "Life of a Ballot" video to see exactly how the Douglas County Elections Office does its job to ensure that your vote counts — just like it's supposed to.



Colorado has been conducting mail ballot elections since 2014 and is regarded as a national model for election integrity, security, and high voter turnout. Your ballot is secure and monitored throughout the election process by cameras, chain of custody logs, and bipartisan teams of election judges from your community who participate in each step of the process.

Ballots for the Nov. 5, 2024, General Election were mailed to all eligible voters beginning Friday, Oct. 11, and you can expect your ballot to arrive by Wednesday, Oct. 23. If you have not done so already, visit DouglasVotes.com to sign up to track the status of your ballot with phone, text, or email notifications from BallotTrax. 

 Helping Develop Leadership in Douglas County - 2024 marks the 25th year of OSNR participation in the Leadership Douglas County programing events. Leadership Douglas County is a program of the Castle Rock Chamber Foundation established to ensure the continuity of knowledgeable and effective leadership in Douglas County. Each year, Open Space staff and volunteers have hosted a class field day at one of the Douglas County's Open Space properties for the participants enrolled in the program. This year's field day was held at Prairie Canyon Ranch in Franktown, which included a tour of the property and natural resource and historical interpretation provided by Open Space staff and volunteers.




Partnering for Wildfire Prevention - Staff from the Pikes Peak District of the Pike National Forest are launching a new environmental assessment (EA) for vegetation management. The EA will identify areas within the analysis footprint in the Pike National Forest in need of treatment, articulate desired outcomes, and authorize various methods for wildfire fuels reduction. This is the next step in the ongoing US Forest Service Wildfire Crisis Strategy process which is intended to create resiliency in the landscape and will draw from lessons learned from nearby management actions. The Forest Service will be working with outside entities, especially established stakeholders and working groups like OSNR, to provide input into the process. Below is a map showing the Colorado Front Range Area included in the US Forest Service Wildfire Crisis Strategy. The Pike National Forest is included within this identified area.








HEART Activity Report - September 2024









HEART Success Story:

HEART received a call from a concerned citizen regarding a male walking alongside the highway. Once
contacted, HEART learned that the male was trying to get to a regional shelter. HEART provided the man
with transportation to a bus station, along with some food, and information about the Ready to Work (RTW)
Program. The male eventually checked into a regional shelter, but also applied for the RTW Program and
was later accepted. The client is currently doing well at RTW and is actively engaged.

Planning Resources

• **Jicarilla Apache Nation Tribal Consultation** - On October 1, 2024, the Curator started tribal consultation with ERO Resource Corporation for the interpretation of the rock shelter project and other archaeological sites in Douglas County. The tribe in attendance was the Jicarilla Apache Nation. The tribe was very interested in the artifacts found at County sites, particularly the pottery. They have a unique style and still make the pottery today the traditional way, which will help us understand the fragments we find in the field. The Jicarilla Apache will continue to consult on the rock shelter project.







History Repository Douglas County Library Coffee Chats - Starting in October, contractor Todd McMahon
and Repository volunteer Mark Howard will give Coffee Chats at the different Douglas County Library
branch locations. The chats take place on Tuesdays and occur at different branches. The citizens in
attendance range from 4-16 people. Topics discussed have included their backgrounds in archaeology, the
Repository collections, virtual museum, archaeology in the Highlands Ranch area, the Lamb Spring site,
Cheese Ranch, Cherokee Ranch history and plans to display artifacts at Parker Water & Sanitation District
offices.

Parks, Trails and Building Grounds

• Fertilizer Program Modifications - This year, Parks staff implemented a new program for fertilizing the 63 acres of natural turf grass that the Division maintains. Research into different formulations and recent advancements in compositions of fertilizer resulted in a type of additive that lasts longer with fewer applications of material.

This "slow release" fertilizer brought the annual applications down to three versus seven applications in the past. The savings for labor and equipment equals 57% or roughly \$12,000 for the Division. Additionally, the fertilizer composition is resulting in a higher quality turf grass that is safer for the environment through less chemicals being added to the soil profile.



Parking Lot Replacement - Paving operations are currently underway at Highland Heritage Regional Park
and Fairgrounds Regional Park. Through assessments with Douglas County Engineering, portions of
parking lots at both facilities were identified for replacement as safety concerns.





Rueter-Hess Reservoir Updates

Trail and Parking Lot Vegetation Removal - From October 6 through October 13, the Rueter-Hess Rangers
conducted trail maintenance and vegetation removal on the Rueter-Hess Incline Trail, Rosie-Rueter By-Pass
Trail, and trailhead parking lots. The Rangers have observed a higher visitation rate for trails due to the
cooler weather. The trail-goers were grateful for the improvements to the trail corridor.



Public Works

Activities for October 7 – October 18, 2024 Active Projects

- West Frontage Road Relocation (aka Dawson Trails Blvd Project) Douglas County and the Town of Castle Rock have partnered to
 construct the new road called Dawson Trails Blvd. Construction
 started on September 9, 2024 and is anticipated to be completed in
 the fall of 2025. For further information about this project, visit: West
 Frontage Road Relocation Project
 - Traffic Impacts: Construction will occur Mon Fri from 7 a.m. to 7 p.m. Saturday work will occur with approval. There will be no construction work on major holidays.



Westcreek Road (84" Storm Sewer Culvert Replacement) Construction starts Monday, October 21: The 84-inch CMP culvert at
14522 Westcreek Rd is experiencing failures within the top of the pipe.
Douglas County Special Projects Engineering will begin replacing this
storm culvert on Monday, October 21, 2024. Weather-dependent, it
will last for approximately 60 days (December 20, 2024).

Traffic Impacts: Westcreek Rd will be reduced to a single-lane temporary road in both directions, and drivers should take care when driving through this area.

- Pinery Outfall Repair Project: Began on July 17, 2024 and is on-going. The Pinery Outfall Repair Project will clean and expose the outfalls that have been located and inspected in the Pinery Subdivision. There are about 40 outfalls that are in poor condition that need cleaning and then repairs. The work being done at this time involves cleaning and exposing the outfalls only, no repairs at this time. Work will be intermittent as crew availability allows. (See map for all locations).
- Pinery Ponds Vegetation Removal Project: This project started on Tuesday, October 8, 2024: Douglas County is analyzing the existing publicly owned detention ponds within the Pinery. The ponds that Douglas County owns are located within Douglas County Open Space. Several of these ponds have large amounts of vegetation that are impacting the surveying of the ponds to determine the next steps in the maintenance process.

Vegetation removal will occur this week, and it should last approximately three weeks, weather dependent. No traffic impacts - work will mainly be done in the open space.

US 85 Widening from Highlands Ranch Pkwy to C-470 Improvements

 Traffic impacts (October 13 - 19, 2024): The last extended closure in a series of paving operations will occur at County Line Road east of US 85 from October 14 – 19. For more information about these closures, visit the project webpage.

Single lane closures on northbound and southbound US 85 and on the C-470 ramps at US 85 from 9 a.m. to 3 p.m. daily, Oct. 14 - Oct. 19, throughout the corridor.

 Ridgeglen Way Storm Sewer Replacement Project: This project began on September 16, 2024 and is anticipated to conclude on November 15, 2024.

Summary of project: Excavation will begin October 9, 2024. This project is going to replace approximately 343 LF of corrugated metal pipe that has reached its life expectancy and install two new manholes for access for future maintenance needs. Driveway and street access will be maintained, but there may be minor delays as Ridgeglen will be a one-lane road during this project.











- West Frontage Road (Town of Castle Rock project) Long-term Closure between Territorial and Tomah Roads - On August 19, crews closed the section of the West Frontage Road between Territorial and Tomah roads. Local access to businesses and residences along West Frontage Road will remain, but no through traffic will be allowed. This estimated 18-month closure will allow crews to safely build the new interchange and relocate this portion of the West Frontage Road to its new permanent location, west of the BNSF Railway tracks. Closure and detour information
- University Blvd (between Crossland Way and Crosspointe) Small UV CIPP Storm Sewer Lining Project –
 Completed Friday, September 20, 2024.
 - Summary of project: Our contractor completed the lining of the storm sewer that goes across University Blvd between Highland Heritage Regional Park and Cheese Ranch Historic Park. A section of pipe in Cheese Ranch Historic Park also needed to be excavated and lined.
- **Dad Clark Gulch 3.0** Naranjo Civil Constructors has completed the installation of 12 riffle drops and is installing soil rip rap (FC#2023-008).





• **Sterling Ranch Filing #7-A and #5-C -** Three Sons Construction is installing storm sewer inlets in Filing #7-A, and Fiore is installing storm sewer in #5-C (DV#2023-410).



• Lansing Residential Subdivision - Libert Infrastructure is installing storm sewer (DV#2123-137).





Cross Creek Subdivision - Martin Marietta is placing asphalt in Phases 1A & B (DV#2023-121).





• The Canyons Subdivision - Clyde Construction is installing sidewalk (DV#2023-323).

The final Rulemaking process through the Water Quality Control Commission will set the Regulations for the State of Colorado's Dredging and Fill permitting system.
 - CDPHE Aquatic Pesticides General Permit Staff attended the Aquatic Pesticides Permit
 presentation put on through the Colorado Stormwater Council and CDPHE on October 10. The
 Aquatic Pesticides General Permit is expected to be publicly noticed for renewal in November 2024.

Sweeping Program: Sweeping operations removes particulate matter and improves air quality to meet
metro area quality standards. Regular sweeping removes sand, debris, leaves, and trash that can cause
unsafe conditions for motorists, bicyclist, and pedestrians. And protects and improves water quality before
it can enter storm sewers and drainage ways.

During this reporting period, sweeping was completed in 16 areas.

A total of 1,727 yards of debris YTD were swept and removed from residential and arterial roads.

Survey research and reconnaissance have commenced on East Parker Road and Miller Road. Another
troublesome intersection in need of safety improvements is pending. This work will include the reclamation
of numerous County G.I.S. Control points within a several-mile radius, which have not been confirmed in
over ten years. This is just another reminder to always check if new developments will impede or altogether
'wipe out' these crucial monuments far in advance of any construction.

Survey assistance was provided in Chatfield Acres along West Lakeside Drive to show roadway rights-of-way for Public Works to commence much-needed roadside ditch maintenance. It was determined that several trees are well within the County's R.O.W. and thus need to be removed. Procedures like this help to keep the peace with neighboring residents by clearly showing where their property starts and stops.

Campaign Highlights

• **Dougnad** - Campaign ran Aug. 21-Sept. 27

Modeled after the Scandinavian tradition of dugnad where citizens meet up with family, friends, and neighbors for coffee and pastries then disperse into the community to do volunteer work such as planting trees or cleaning parks.

The purpose of Dougnad is to inspire generational public service and reinforce the value we place in Douglas County on keeping our public spaces clean, safe and enjoyable for all.

In partnership with Parks and Open Space, Communication and Public Affairs launched a campaign to recruit volunteers for a day of service in Highlands Ranch, at Glendale Farm Open Space and at Challenger Park.

Tactics included both digital (emails to subscribers, organic social media, paid social media, digital advertising with the Castle Pines Connection, a web page and our online newsroom) and grassroots (flyers to school district, outreach at churches, and outreach at the dog park.)

Results:

- o 93 volunteers recruited for Challenger Park
- More than 50 volunteers at Glendale Farm Dog Park. (Two saw the announcement. Others recruited on site.)
- o 35 volunteers at Highlands Ranch's Renew the Ranch

- 130 scans of the general flyer QR code (shared with churches and open space volunteers)

• **Healthy Families Partnership Launch** - The initiative officially launched at Sky Ridge Hospital with a press conference on Sept. 18.

Together, Public Works and Communication and Public Affairs hosted a media day on Sept. 18. All Denverarea and local media were invited to Public Works Operations in Parker to hear from Dan Roberts, interview operators, ride in a snowplow and drive a snowplow simulator.


Results:

Commissioner Work Session – October 8, 2024

• EPIC Assessment of Childcare Expansion in Douglas County - At the direction of the Board in December 2023, EPIC was contracted to perform an assessment of childcare expansion in Douglas County and they presented the key findings and recommendations from the assessment. Key findings identified a significant shortage of childcare options for infants and toddlers due to lack of qualified staff, limited available programs and financial considerations. Short term recommendations included offering comprehensive training and certification programs to individuals (including involving older adults) and create a program using authority granted by SB24-002 to reduce the tax burden for childcare providers to reduce overall costs

of doing business. Long-term recommendation would include opportunities to expand services by development of new opportunities and corporate partnerships.

Motion - Approve the two recommendations (1) \$40,000+ to fund the training for seniors to participate in childcare and (2) authorize staff to proceed to formal action by the Board to recognize the tax credit and implement its use in the County. Passes 3-0

Water Commission Referral Process - Staff provided a proposed process for the Water Commission to
review projects that impact water, provide a list of projects that can be selective not to overload the
Commission and distract from its work on the water plan. The specific projects to refer to the Commission
was discussed and the existing review process for those. Suggestion was made to provide the approval
criteria framework and other referral agency requirements for the Commission to work with; getting one
referral document from the Commission (it was decided that any Commission member be allowed to
comment individually). Commissioners expressed support for the process proposed.

Commissioner Work Session – October 14, 2024

- Business Personal Property Tax Incentive Request Lakewood Electric Company, Inc. A request for BPPT rebate was submitted to the County for consideration. A representative of the Company was in attendance to provide background on the Company and staff confirmed that the Company meets the eligibility criteria for the rebate.
 - **Motion** Direct staff to prepare the necessary agreement for business personal property tax incentive for approval at a Business Meeting. Passes 3-0.
- **BEAD Grant Requests for Letters of Support** Staff provided information on three organizations applying for grant funding from the State's allocation of the federal Broadband Equity, Access and Deployment Program (BEAD). The companies requiring a letter of support from the County are Conexon, Maverix and Thrive. Information on the location of services to be provided was presented and discussed.
 - **Motion** Approve the three letters of support as presented and would welcome follow-up information when available. Passes 3-0.
- **2025 Budget Discussion** Staff continued with the preliminary budget discussion. Subsequent meetings will be scheduled for more detailed discussion related to the various categories.
