	Short-Term Rental" means the rental of a Lodging Unit for a term of less than thirty (30) consecutive days.	
	Short-Term Rental Property" means a Lodging Unit available for lease for a term of less than thirty (30) consecutive	days.
	Vacation Rental Service" means a person that operates a website or any other digital platform that provides a means hrough which an Owner or Local Responsible Agent may offer a Lodging Unit, or portion thereof, for Short-Term Ren nd from which the person financially benefits.
